Feature Article

GNAS AGM

I attended the AGM on Saturday 29 April 2000 at Lilleshall (which is to be the new HQ for GNAS in the next few weeks) on behalf of my club, as proxy for a number of other clubs and as Chairman of Devon & Cornwall. Good-byes were said to the retiring Chief Executive, John Middleton and several of the office staff from Stoneleigh (who will not be moving to the new venue). Hellos were said to the new Chief Executive, David Sherratt and new GNAS Admin staff. (As nearly all of the admin staff are brand new to the job with only a few weeks overlap with former admin staff, please be patient with them as they "learn the ropes"- Ed)

The main order of the day at the EGM (which followed the AGM) was the proposal by National Council to adopt new Articles of Association. The meeting was addressed by Peter Greaves (describing himself as the new Director for England if the proposals were implemented) who proceeded to give a history of the development of GNAS to demonstrate how archaic its structure is. You may have seen his article in the Spring Edition of Archery UK on these important changes to the Society and some may have seen his briefing paper issued to Club Secretaries with the AGM notice about a month ago. He described the National Council's approval of the Review Committee's suggestions as "the turkey's voting for Christmas" as the majority would be out of a job if the proposals were approved. Decision-making would be reduced from a Council of 23 members to a Board of Directors of 9 members, but this level of consideration would only be needed for deciding the direction of the company's business. More importantly, archery-related decisions could he made by the Operations Committee, which will be empowered with full autonomy on such matters. This should seriously speed things up. Little was said to expand on those points, but he did emphasize the Centre's intention to get closer to the grass roots archer and address the Society's responsibilities to those archers more directly.

Much (often fierce) debate ensued - especially the hot potato of collecting subscriptions from each archer directly by the Centre (NO decision has been taken on that yet - but John Alcock, as the new Director of Finance designate, did allude to this being "attractive" in view of the flexible ways in which it could be arranged: direct debit, etc.). It is fair to say that most of the speakers, including myself, were cautiously in favour of the new improved structure, but critical of the seeming rush at the 11" hour (from a Committee who have been considering these issues since 1997!) when so many questions about how the new structure will operate and fit in with existing structures (Operational Committees, Judging & Coaching, Regional & County Societies, etc) have still not been spelt out clearly.

The Presidents address at the AGM (read out in his absence by Nick Nicholson as Vice President) had talked about "a leap of faith" when the Society moved out of domestic quarters to Stoneleigh many years ago and concluded with the advice regarding the change: "We can, we will, we must".

The issue went to a ballot vote with 554 votes for the motion to change and 145 against (ie over 3/4 majority in favour). Accordingly, the new Articles were adopted (and the consequences which go with them - whatever they are).

This ushers in an era of change, from the Centre, through the Regions to the Counties and right down to the archer, which we should face squarely and positively.

- ➤ Good shooting was seen at the "Clipper" Tournament held by Brixham Archers in February, comprising a Record Status Double Portsmouth qualifying round followed by an Olympic-style shoot-off for the top 8 Senior scorers in the recurve and compound disciplines.
- ➤ Good results were also obtained at the Grand Western Regional Indoor Championships at Weston-super-Mare in February. It was so cold (Hutton Moor Leisure Centre heating not working again) that inclement weather was declared indoors!
